

ACTIVITY REPORT June to September 2022

Mandates and responsibilities:

- Fishing and Trapping Support Program: overall program administration, technical assistance to Community programs and management of the regional program
 - Uumajuit Wardens Program: wildlife protection on the land in the marine sectors;
 - Environmental Program: technical assistance to the Northern Villages, environmental monitoring, research, climate change and environmental projects;
 - Land Use Planning: technical assistance to the Northern Villages and regional planning;
 - National Parks development and operation.

1. INUIT HUNTING, FISHING AND TRAPPING SUPPORT PROGRAM

- The second payment of the community grants were paid to the NV's in an amount of \$3,652,648 including the indexation;
- The construction of a landing barge for Kuujjuaraapik tender process is done, the community should receive the barge next summer by sealift 2023;
- The construction of the community freezer for Quaqlaq went out for tender and was not accepted by the community but will be sent out for tender again with more specific specs;
- The Tasiujaq HSP community boat is now in fabrication and will be ready to be picked up summer of 2023;
- The Nunavik Land Mobile Radio projects is in the process of being worked on for Tasiujaq, Aupaluk, Kangirsuk and Quaqlaq, the material will arrive end of September and will be worked on during the first week of October. Ivujivik, Inukjuak, Umiujaq and Kuujjuaraapik will resume in 2023.

2. UUMAJUIT WARDENS PROGRAM

- As of the end of August the wardens completed 575 patrol-days and 6 days of search and rescue assistance;
- Weekly conference calls with the wardens ongoing;
- Weekly reporting on Beluga sightings and harvests along with monitoring of hunting on a daily basis, ongoing with each warden;
- As part of the Nunavik Indigenous Guardians Initiative, the Wardens continue to document and report observations on environmental and climate changes on the land;
- Participated in the monthly meetings of the KRG/DFO Liaison committee;
- Joint patrol with MFFP and Uumajuit wardens in some communities;
- Recruitment for a warden in Aupaluk is on going;
- Refresher courses planned first week of October;
- 4 wardens were trained by the CCGA Quebec as recognized Transport Canada Boat Courtesy Inspectors, Charlie Kumarluk, Putulik Cameron, Zeb Annahatak and Michael Cameron, training organized and paid for by the CCGA Quebec;
- Assist the CCGA in Inukjuak to finalize the on water certification of the crew that started their rescue boat training.

3. ENVIRONMENT

Residual Material Management

- Participated to the 13th meeting of the Nunavik Waste Management working group in June, the main items on the agenda were proposing amendments to the funding agreement, updating eco-center project, composting project, facility center for EPR products, waste to energy project with SPN;
- Submission of a KRG-brief to Quebec Government regarding the new regulations of the application of environmental certificate authorization;
- KRG received confirmation of funding in July from Ministry of Environment for the all the waste management projects in progress for a total of 10,2 millions \$: Metal recycling (Kangirsuk), Eco center (Kuujjuaq), Composter (Inukjuak) and Recycling facility (Kangiqsualujjuaq);
- Launching of metal recycling project in Kangirsuk: equipment arrived on sealift at the end of July, consultants began sorting metal on site, metal press and decontaminating the end of life vehicles. An average of 25-30 tons of metal are treated every day; at the end of August about 60% of the old landfill metal accumulation was treated; this project should be finished by the end of 2023;
- The working group for the waste to energy project in Kuujjuaq has been re-established with the NV, the KRG and the Société Plan du Nord, this project started in 2015 but was put on hold due to covid situation, more feasibility studies are to be done by the KRG prior to make this project a reality;
- Eco center project in Kuujjuaq: plan and design for this project are ongoing and the project will initiate its first phase at the end of August (preparation of site);
- Planning phases for the composting project in Inukjuak and Recycling facility center in Kangiqsualujjuaq are ongoing;
- Submission of new funding requests under Recyc-Quebec program for supporting remote areas in Quebec; few waste management projects will be submitted for the region (including construction of new infrastructure for storage of end-of-life vehicles);
- Beginning the recycling summer operations with all the NVs (used oil, paint, electronics, tires, batteries, fridges and freezers...). Multiple containers already shipped south for recycling, total quantities will be shared in the next activity report after the sealift season.

Spill Management

- During the reporting period, 47 spills were reported to the KRG: 14 from mining companies and 33 reported or observed from regional organizations;
- Of the 33 spills from regional organizations, 22 were reported by KRG's environmental specialist;
- Environmental prevention inspections were undertaken in Kuujjuaraapik, Puvirnituq, Akulivik, Ivujivik, Salluit, Kangirsuk and Kuujjuaq on heating oil tanks and drums to identify leaks or possible non-compliance; the owner of the buildings have been contacted;
- Meeting with INRS (Institut de la recherche scientifique) as part of a research and development project for the rehabilitation of a site located in Kangiqsualujjuaq; this project aims to find a solution to treat contaminated soil under the building without excavating;
- Discussion with Avataani Environmental Inc. for the implementation of an authorized Treatment Center for soil decontamination in Puvirnituq;
- Training sessions on Spill response and Hazardous waste management have took place during July in the NVs of Kuujjuaraapik, Puvirnituq, Akulivik, Ivujivik, Salluit and Kangirsuk; a total of 48 participants were able to take part in the training provided by MELCC inspectors in collaboration with the KRG.

Quarry and Borrow Pits

- A presentation was given to the municipal council of Kuujjuaraapik on July 14th concerning the actual sand pit, the potential option for enlargement, restoration preference as well as the possible location for a new gravel pit;
- Analysis and test for sand pit road access options have taken place in the NV of Umiujaq with geomorphologist and biologist consultant from July 27th to 30th;
- The MERN Lease was successfully delivered to the NV of Kangiqsualujuaq for their gravel pit;
- Test pits were performed in the NV of Aupaluk, from August 7th to 8th, to identify the best location for a new sand pit;
- Various funding has been found for the restoration of abandoned sand pits within the municipal boundary and fieldwork were made in the NVs of Puvirnituk, Kuujuaq, Kangiqsuaq, and Quaqtaq, in July and August, to analyze and prepare the work to be done if funding is approved.

Climate Change Adaptation and Monitoring

- Phase 1 of fieldwork was held in the NV of Kangiqsualujuaq, from June 18th to 24th, for the pilot project :“Characterization of wetlands and water environments in Nunavik ” with the consultant, KRG and MELCC.

Environmental Research

- Monica Nashak, Inuit Research Advisor has chaired for the first time at the “Nunavik Nutrition and Health Committee” meeting held at the end of May. Reviews of the different research proposals for the region under the “Northern Contaminants Program” by Federal Government;
- Participated at the end of May in virtual discussion organized by Researcher Mary Gamberg on “Caribou Contaminate Planning Discussion”. All different arctic regions took part in this discussion to determine if there are some samples that can be taken from vulnerable declining populations of Caribou across the arctic;
- Took part in NRRA discussion at the beginning of June on naming the new research entity that will oversee research projects that takes place in the region. Different words were gathered that might be a fitting name that most reflect research in Inuktitut. It was decided and one name was agreed upon. This announcement should be released in the fall;
- Participated at beginning of June in a virtual “Qanuillirpitaq” discussion of results on animal bites and scratches organized by Nunavik Regional Board of Health and Social Services;
- Participated at Marralik Research camp organized by Nunavik Hunters Fishing and Trapping Organization RNUK. This camp is located between the villages of Kuujuaq and Kangisualujuaq on Ungava Bay. This is the second year of operations for this camp where scientists, hunters, land users, youth and elders exchange their knowledge;
- In August, the Inuit Research advisor participated in person to a Vancouver “Research Ethics on Health” training as part of the Nunavik Nutrition & Health Committee.

Regional Environment

Caniapiscau Watershed Abandoned Outfitting Camp Clean-up:

- Communications with ECCC to finalize an amendment to the Agreement for Caniapiscau Watershed abandoned outfitting camp clean-up; this amendment once signed will extend this project until 2026;

- Collaboration with MFFP concerning the list of the mobile camps to be inspected in September; these inspections will be held in collaboration with Naskapi Nation representatives.

Nunavik Abandoned Mineral Exploration Sites Restoration:

- Rehabilitation work completed in Kangirsuk vicinity:
 - June 10 and 15, the KRG environmental technician and eight local workers completed the clean-up of 3 sites on the other side of Payne River; retrieving more than 75,000 kg of waste left on the land from previous mining exploration companies;
 - July 20 and 24, the KRG environmental specialist and eight local workers completed the clean-up of eight other abandoned sites; during this working session, a presentation and helicopter tour was provided to the NV board members to show the fieldworks results.

4. LAND USE PLANNING

Regional Planning

- Letters of Conformity: during this period, **four** projects of Land use occupations for mineral exploration activities and studies were approved and **one** project for the construction of an extension to a private fishing camp was refused;
- A meeting with the KEAC was held on May 27th to present the last version of the Kativik Region Zoning Bylaw;
- The proposed amendments to the Kativik Act were sent to Makivik Corporation, on June 10th for comments;
- A meeting with the Kativik Regional Advisory Committee and the Nunavik Landholding Corporation Association was held on June 15th to present the latest version of the Kativik Region Zoning Bylaw;
- A meeting with the MAMH was held on June 17th to present briefly the context behind the Kativik Region Zoning Bylaw;
- Meeting with the MERN was held on June 16th concerning leases and land uses on the Kativik region; the MERN mentioned concerns regarding the change of status from permanent outfitting camps to traditional camps, it could be seen as a way to avoid rehabilitation of these camps; the KRG will work in collaboration with MERN and the owners of these camps to make sure this change of status does not lead to new abandoned sites on Kativik region.

Municipal Planning, Expansion Plans and Technical Assistance Program

- Technical assistance was provided to: Salluit, Kuujuaq, Kangiqsujaq, Kangirsuk, Umiujaq, Inukjuak, Puvirnituk and Quaqtaq for consistent integration of construction projects into NV land use plans;
- Planning and coordinating the community expansion areas for 2022-2023, the land use planners team met with the NVs of:
 - Umiujaq, Salluit and Kangiqsujaq in June for a presentation about the 3 comprehensive expansion plans for adoption;
 - Inukjuak and Kangiqsujaq in June concerning the completion of their master plan update;
 - Puvirnituk in June to initiate the master plan process;
- Increased the collaboration with the KI, health board and Makivik to optimize the efficiency of the new construction projects, meeting was held with KI representatives in June in order

to understand their future need in terms of infrastructure developments and better integration into the land use planning of the 14 NVs.

5. PROTECTED AREAS

20% Protected Areas

- Several meetings with the consultant were held to plan the consultation project on protected areas, which will be implemented starting in the fall of 2022. Website and Facebook page for the consultation project were finalized in Inuktitut, Cree, Naskapi, English and French; both will be launched in September;
- Specific Agreement to preserve the Cambrien Lake / Nachicapau Lake / Fort Mackenzie (Waskaikinis) Areas:
 - Subcommittee meeting on the implementation of specific commitments regarding mining activities in the Nachicapau Lake Area took place July 7th;
 - Participation in working sessions with Naskapi and MELCC representatives for the production of Cambrien / Nachicapau Status Report;
 - An aerial survey over the Cambrien / Nachicapau lakes sector by helicopter occurred on June 2nd and 3rd to identify golden eagle nests, which is a species under the "vulnerable" conservation status according to the Quebec Act respecting threatened or vulnerable species;
 - Participation in the 2022 Knowledge acquisition fieldwork campaign in the Cambrien and Nachicapau lakes sector in collaboration with the Naskapi Nation of Kawawachikamach. KRG Park Planner and Environmental Technician took part in the field study, collecting wildlife data from August 14th to 28th. Archaeological, geology and botany studies were also conducted by various specialists.

Park project

- 10th meeting of the Iluiliq National Park Project Working Group held in Salluit on July 27th-28th. Results of geology studies in the sector of the study area by the MERN in the recent years were presented to the working group, as well as the Québec Government's position on the proposed limits for the park. From now and until the next meeting, the members of the working group will collect their organization's comments on the proposal;
- Aerial survey by helicopter of Iluiliq National Park Project with an Air Inuit pilot to assess the potential landing strips within the sector occurred on September 9; this accessibility information is essential for the development of the project.

6. PARKS

General

- Visitors arriving from south resumed this summer;
- A COVID-19 isolation and evacuation procedure was drafted to ensure the safety of the visitors and employees in the event of a potential COVID-19 case;
- The agreement with FCNQ Voyages was renewed. Nunavik Parks is working with this travel agency to book all-inclusive packages in Nunavik;
- A draft of the emergency measures plan was shared with employees to pinpoint risks in parks and have a preparedness plan in case of emergency;
- Refresher course was delivered by a Quebec wildlife protection officer on June 7 to all wardens to renew their status as wildlife protection assistants;
- Wardens and conservation and educational specialists participated with Quebec Wildlife Protection Officers in patrols in each of the 4 parks;

- The mandate of the Harmonization committee was updated and presented to all members;
- Nunavik Parks winter packages dates were released;
- Department director and assistant director met with the Parks advisory committee in Quebec in June;
- Welcome Snap Quebec with their Plan Nous participant in Pingualuit and in Tursujuq. This project aims to create links through the meeting of representatives of different communities, and to discover the richness of the landscapes and enhance the biocultural diversity of Quebec;
- Hiring of 6 summer students in 3 communities: Umiujaq, Kangiqsujaq and Kangiqsualujjuaq;
- Olivier Paradis, former visitor experience officer in Kangiqsualujjuaq, was hired as a temporary visitor experience technician.

Pingualuit

- There were 41 visitors in the park and 81 at the visitor center during this period, as of August 15;
- This summer, 18 booked for the long packages including a stay in Kangirsujuaq for 2 days before going to Pingualuit, about 45 for the short packages and 24 for the weekends;
- All employees took part in the Inuit games training with Qiallak Qumaaluk on July 13 and went on the land with Minnie Etidloie to learn about plants with literacy summer campers;
- All employees and helpers had an emergency plan training on July 18;
- A helicopter was chartered to Manarsulik for the opening, maintenance of camps and the airstrip, installation of educational panels, conservation & environmental sampling, safety inspection and to check the two airstrip options;
- 4 landing authorizations were issued to two visitors who went to Pingualuit on their own plane, to Canadian Royalties and Glencore to do their environmental monitoring and to MFFP to do the Leaf River caribou herd survey;
- Airside vehicle operator permit (AVOP) training was undertaken by the park's employees. This certifies that a person is trained to operate vehicles safely airside in gate, runway and aircraft taxi areas;
- Environmental monitoring was done in July including water quality monitoring, water level, soil and air temperature, as well as Manarsulik camp bank erosion, crater trail and archeological site monitoring by photo;
- Education technician visited the park's team and the pavilion to assist with the exhibition and educational tools;
- Harmonization committee meeting was held in Kangiqsujaq on June 6. Some subjects discussed included a presentation of conservation work requests for 2022, summary of winter operations, zoning and expansion project;
- James Greig was hired as operations coordinator.

Kuururjuaq

- There were 36 visitors in the park and 40 at the visitor center during this period, as of August 15;
- This summer, there are 5 Iberville packages and 4 weekends in Qurlutuarjuq;
- Harmonization committee meeting was held in Kangiqsualujjuaq on June 8. Some subjects discussed included; mandate of harmonization committee members, a presentation of conservation work requests for 2022, summary of winter operations. Two wildlife protection agents presented their role and discussed the responsibilities of wildlife protection officers and wildlife protection assistant. The collaboration between Wildlife Protection Direction and Nunavik Parks is very good;

- Environmental monitoring was done in July including water quality monitoring in the Koroc river, water level in the Koroc and Narsaguluk, soil and air temperature in Qurlutuarjuq and Iberville, permafrost study, Koroc river access bank erosion monitoring by photo;
- Schrubification monitoring: vegetation survey was conducted in 12 stations targeting gaudulous birch;
- 2 campaigns were done for the tele-detection project in collaboration with UQTR;
- The Governor General of Canada, Mary Simon, visited the park's pavilion and met with the employees in May;
- A helicopter was chartered to Kuururjuq for the opening, maintenance of camps and the airstrip, sling material and proceed with conservation & environmental sampling;
- Kuururjuq director, coordinator and Parks assistant director met with the Cooperative management board of Torngat Mountain National Parks at the base camp to share updates, priorities and opportunities;
- Imaapik Brazeau was hired as a park warden;
- Jason Annanack resigned as a park warden. The hiring process for another park warden is underway;
- Saladie Snowball, visitor experience technician, is taking a year off work. The hiring process for her temporary replacement is underway.

Uliittaniujalik

- There were 2 visitors in the park during this period, as of August 15;
- Harmonization committee meeting was held in Kangiqsualujjuq on June 9. Some subjects discussed included mandate of harmonization committee members, collaboration with École d'architecture and a presentation of the master plan by the MFFP;
- Environmental monitoring conducted by the Conservation and education specialist.

Tursujuq

- There were 58 visitors in the park and 72 at the visitor center during this period, as of August 15;
- Parks guided 3 weekend packages and 1 full package;
- Parks had 3 groups of autonomous white water paddlers coming from south;
- A weather station was installed at Wiyâshâkimî airstrip in June. The data will soon be available online to increase safety when accessing that area of the park. A partnership regarding the transmission of the data is underway;
- Multiple trips by Twin Otter were done from CEN airstrip to Umiujaq to retrieve material from the clean up project conducted by Nancy Dea. There was a good collaboration between their organization and Tursujuq team;
- Research authorization and flight/landing authorization were issued to MFFP for the caribou survey of the Leaf River herd;
- Jack Nivixie was hired as the operation coordinator;
- Samson Crow was hired as a seasonal warden;
- Hiring of visitor experience officer in Umiujaq as well as in Kuujjuaraapik is underway.
