PUBLIC NOTICE

Is hereby given by the Kativik Regional Government (KRG) concerning

BIDS FOR USED VEHICLES AND EQUIPMENT IN NUNAVIK, QUEBEC

The KRG solicits bids from any person, legal or natural ("the bidders"), for the acquisition of fifty-nine (59) used surplus vehicles and equipment ("the lots") which are located within the various communities in Nunavik, Quebec. The terms applicable are detailed below, together with a description of the lots.

Terms

1. The KRG reserves the right to modify the present call for bids until the deadline for the submission of bids;
2. The KRG provides, in good faith, a description of the contents of each lot, as well as pertinent information on its present condition. Lots are offered for sale on an "as is, where is" basis, i.e. each item is sold as seen, at the risk of the bidder who will be awarded the lot ("the successful bidder");
3. No warranty, express or implied, statutory, contractual or oral, is made by the KRG as to the quality, nature, character, quantity, weight or size of the lots, nor with respect to their condition or fitness for any use or purpose whatsoever;
4. The KRG cannot be held responsible for any omission or incomplete examination of the lot by the bidder. Any bidder acknowledges having examined the lot and declares itself fully satisfied with it;
5. Any person who examines, and any successful bidder taking possession of, a lot on the storage premises in the communities is liable for any damage, direct or indirect, material, bodily or moral, accidental or intentional, caused by him/herself, his/her representative, his/her agent or any person accompanying him/her;
6. Any bidder wishing to withdraw his/her bid must do so in writing to the Legal Department of KRG before the deadline for the submission of bids;
7. Each lot is awarded to the highest bidder, subject to acceptance of the sale by the KRG. The KRG shall not be obliged to accept either the highest or any other bid;
8. As soon as possible following the award, the KRG contacts the successful bidder for each lot using the contact details indicated in its bid. The KRG cannot be held responsible for any communication failures or difficulties attributable to the successful bidder or to force majeure;
9. The successful bidder must proceed with full payment, in cash, via Canada Post money order or by certified cheque, sign the deed of sale, take possession of the vehicle and remove it from its current location within two (2) days of being contacted by the KRG. If the successful bidder does not comply within the allotted time, the KRG may dispose of the lot at its discretion;
10. Please note that the KRG will only contact the winners of each of the bids found in the present call for bids. Consequently, bidders are asked to refrain from contacting the KRG regarding the status of their submission. The KRG will not respond to any communication received regarding the status of a given bid except where the individual in question is the winning bidder.
11. For further clarity please note that the 2-day delay mentioned in section 9 only comes into effect when the bidders are invited to sign the deed of sale and make payment. As such the email or phone call by which bidders are informed that they have one a given lot does not trigger the 2-day deadline.

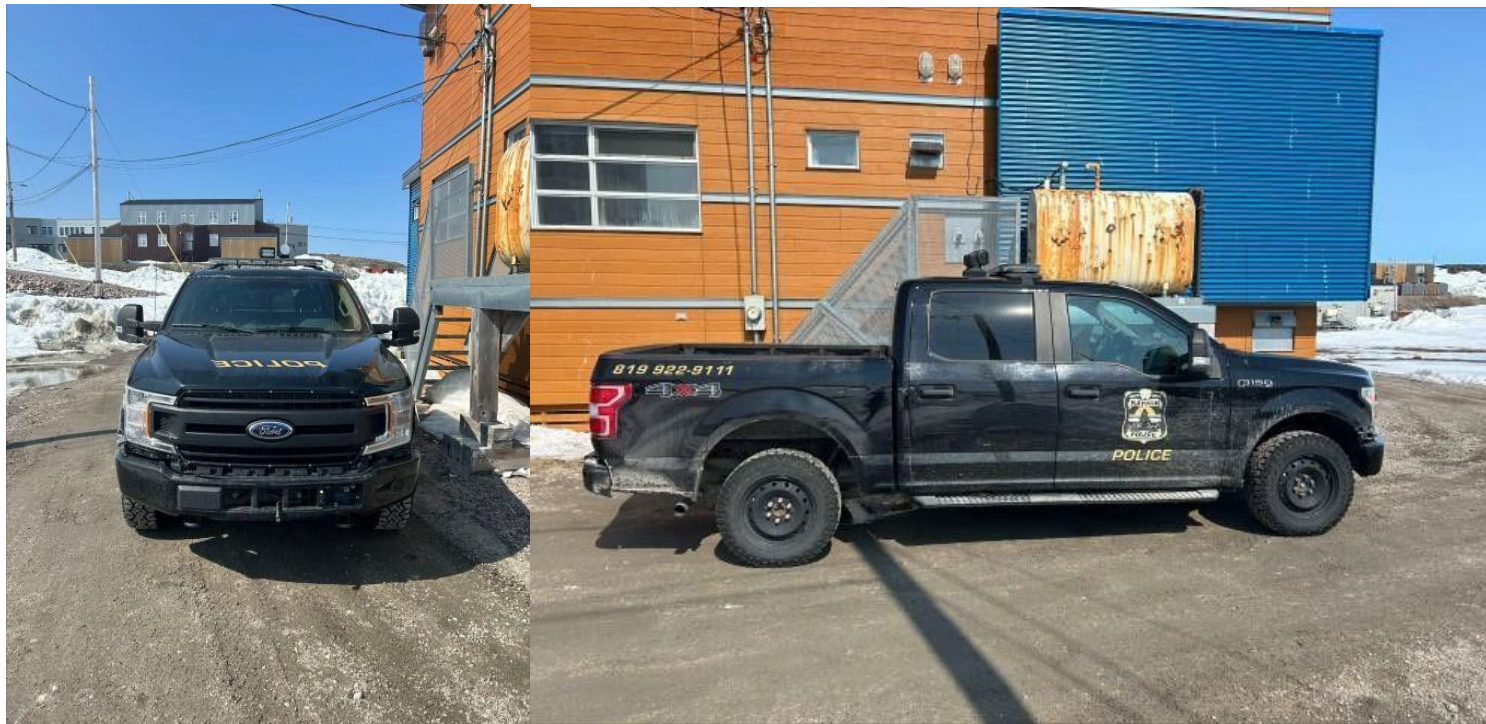

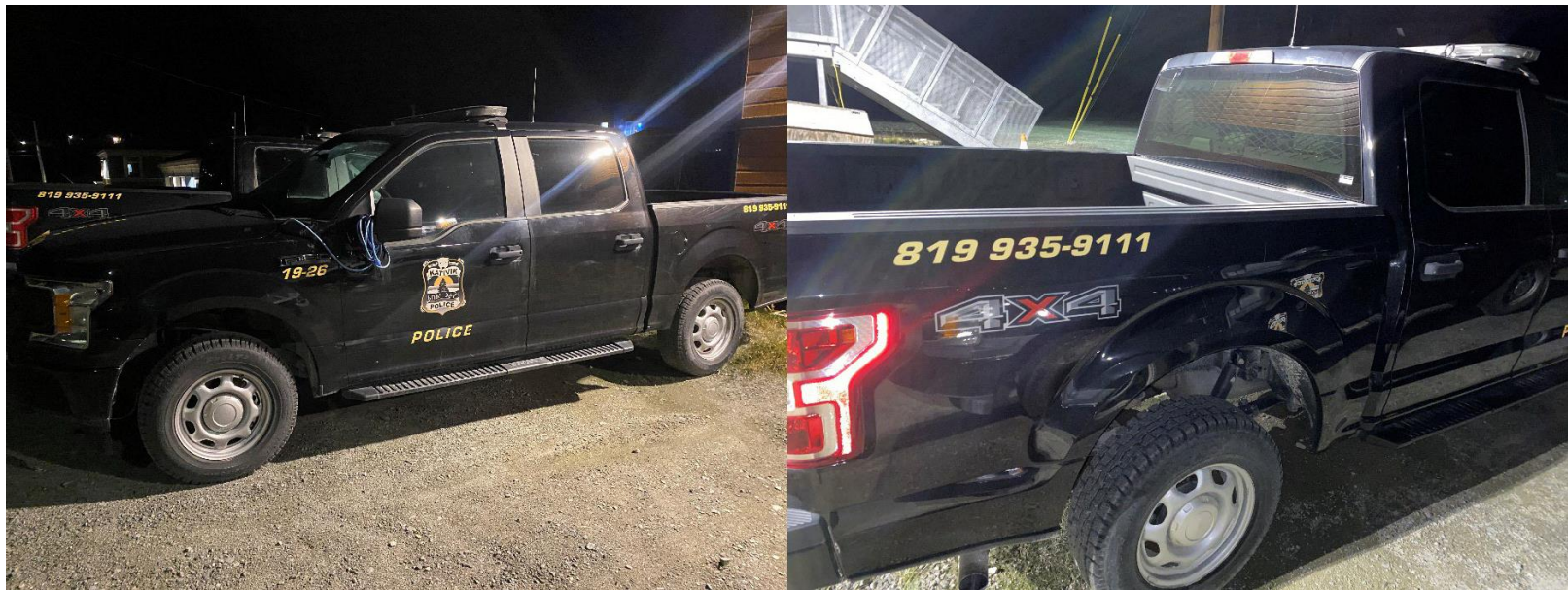
